Medical Center: support of four family resource centers, with medical clinics, for uninsured children that are staffed and operated by the four school districts in York County.

DPIL: help families read together by sending new, carefully selected books from DPIL foundation. Each month, a new book is mailed to the child's home in their name from ages birth to five years of age.

4c (Code:) (Expenses \$ **24,791** including grants of \$) (Revenue \$ **46,500**)

ROAR: training local doctors and staff in this program where new, age-appropriate books are provided for each child 6 months to 5 years who come for a well-child visit and that the doctor gives anticipatory guidance to parent. Gently loved books are also provided to siblings. Doctors use this opportunity to educate parents about the importance of reading and talking to the child and the relationship of these early literacy activities to brain development.
