Employer matching programs – Courtney Guenther

Courtney Guenther: I worked at an organization that matched donations; you may want to check to see if your employer does. Companies have to approve the organization. If you haven't made your board pledge yet, this may be a great opportunity!

Laura Moore: Sometimes it works for mates as well, your spouse's employer may have a matching program.

- Talking points Rachel
 - What do you know about the Community Reinvestment Act (CRA)? See the attached fact sheet from the Federal Reserve. When you're promoting ELP especially to financial institutions, please mention that we primarily serve low- to middle-income families, an integral component of CRA.
 - According to ELP's 2022 990, 75.7% of our spending goes to program costs. Over 75% is good. Potential funders and donors refer to this information when making decisions about contributions.

RHH: Jim could you speak a little on CRA?

Jim Reno: Sure, I'm excited, on an education related board, to have a chance to talk about something related to banking!

CRA:

- Put into place in the 1970s
- Designed to encourage banks to help others. There are
- 5 different types of evaluations
- Banks are looked at for lending, investment, and community service
- Banks have a CRA rating that is looked at by bank examiners
- Certain criteria has to be met for nonprofits the ELP website helps, you can see form the website that we serve low to moderate income families

The take away is that you can say with confidence that banks giving to ELP are getting CRA credit. Hopefully this will help you solicit donations from banks!
